- footings before pouring concrete
- foundation inspection before backfill
- plumbing, heating, framing, insulation and electrical inspection before any closing in of the framework
- final inspection upon completion of all work
- No occupancy is permitted without a certificate of occupancy issued by the Building Inspector/Code Officer

****THE ABOVE INSPECTIONS REQUIRE A 48 HOUR PRIOR NOTICE****

The following items must be submitted with the building permit application:

A plot plan of the parcel depicting existing new buildings and proposed new construction. Delineate the area from building structures existing and proposed to all property lines. Distance measured in feet must be shown to the front sides and rear property lines. Plan must be drawn to scale and accurately dimensioned.

Two complete sets of stamped plans and two complete sets of specifications showing the proposed scope of work to be performed, the materials and equipment to be used and installed, and details of structural, mechanical and electrical and plumbing installations. A permit and certificate of approval must be obtained from the NY Board of Fire Underwriters for all electrical work.

Any deviation from the approved plans must be authorized by the approval of revised plans subject to the same procedures established for the examination of the original plans.

Proof of liability insurance for contractor.

NYS requires proof of Workers' comp and disability or proof of legal exemption from them.

Cash or check made payable to the Town of Coxsackie for the permit fee. The cost for the building permit is calculated by square footage and must accompany the application. The fee schedule can be found on the Town's website www.coxsackie.org.

With the issuance of this permit the Building Inspector, his assistants or code enforcement having jurisdiction under the NYS Uniform Fire Protection and Building Code, and the NYS Energy Conservation Construction Code has permission of the owners and/or the contractors to enter upon any building, structure or premise covered by the permit at any reasonable hour and no person shall interfere with the performance of their duties.
